Friends of Adanu support includes partnering with universities (NYU, University of Washington, Alma College and NYU Accra), organizations and corporations (Global Hope Alliance, VIMA, Mosaic, Trip of a Lifetime). These partnerships led to 104 volunteers going to Ghana to work in 8 communities, directly impacting over 2000 people. Volunteers worked with students, teachers and community members to encourage the community's efforts, worked on construction and research projects, and participated in cultural immersion activities.

4b (Code:) (Expenses \$ 220,931. including grants of \$ 111,884.) (Revenue \$ 0.)

Money raised in 2016 by Friends of Adanu went towards 10 projects: 2 libraries, 3 WASH projects, a school garden and mushroom house, a playground, 2 pen pal projects, and painting a school. The results have been substantial - students have classrooms to learn in, clean water to drink during the day, and privacy when using a bathroom. Libraries, outfitted with electricity, host special classes each day, and allows students and teachers alike to study and read after school. Children have a designated place to have fun in the playground, and the garden can grow food for school lunches.

Our ongoing partnership with New York University Stern School of Business focused on building a 3-classroom school, a clean water project, and the creation of a women-run social enterprise project. This project successfully trained women and men to create batik fabrics to sell locally and abroad. It also offers the community economic diversity, which is critical as the local fishing catch has dwindled alarmingly in the past two years. The income generated by the Batik Center is helping pay for children's books, paper, pens and uniforms for school.
